# SECTION 4: FIRST-AID MEASURES

**4.1 General Advice:** Consult a physician. Show this safety data sheet to the doctor in attendance. Move out of dangerous area.

# 5.2 Unsuitable Extinguishing Media:

# 5.3 Specific hazards arising from the chemical

Static charges generated by emptying package in or near flammable vapors may cause flash fire. Fire may produce irritating, corrosive, and/or toxic gases.

#### 5.4 Special protective equipment and precautions for firefighters

Firefighters must use standard protective equipment including flame retardant coat, helmet with face shield, gloves, rubber boots, and in enclosed spaces, SCBA. Structural firefighters protective clothing will only provide limited protection.
