- 5.2 Unsuitable Extinguishing Media:**
Do not use a solid water stream as it may scatter and spread fire.
- 5.3 Specific hazards arising from the chemical**
Static charges generated by emptying package in or near flammable vapors may cause flash fire. Fire may produce irritating, corrosive, and/or toxic gases.
- 5.4 Special protective equipment and precautions for firefighters**
Firefighters must use standard protective equipment including flame retardant coat, helmet with face shield, gloves, rubber boots, and in enclosed spaces, SCBA. Structural firefighters protective clothing will only provide limited protection. from entering drains. Absorb in vermiculite, dry sand, or diatomaceous earth, and place into containers.

Small spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination.

Never return spills in original containers for re-use. This material and its container must be disposed of as hazardous waste. Collect and dispose of spillage according to local regulations.
