- 5.3 Specific hazards arising from the chemical

Static charges generated by emptying package in or near flammable vapors may cause flash fire. Fire may produce irritating, corrosive, and/or toxic gases.

5.4 Special protective equipment and precautions for firefighters

Firefighters must use standard protective equipment including flame retardant coat, helmet with face shield, gloves, rubber boots, and in enclosed spaces, SCBA. Never return spills in original containers for re-use. This material and its container must be disposed of as hazardous waste. Collect and dispose of spillage according to local regulations.


