SECTION 4: FIRST-AID MEASURES

4.1 General Advice: Consult a physician. Show this safety data sheet to the doctor in attendance. Move out of dangerous area.

If Inhaled: Remove to fresh air. If not breathing, give artificial respiration or give oxygen by trained personnel. Call a physician if symptoms develop or persist.

5.2 Unsuitable Extinguishing Media:

Do not use a solid water stream as it may scatter and spread fire.

5.3 Specific hazards arising from the chemical

Static charges generated by emptying package in or near flammable vapors may cause flash fire. Fire may produce irritating, corrosive, and/or toxic gases.

5.4 Special protective equipment and precautions for firefighters

Firefighters must use standard protective equipment including flame retardant coat, helmet with face shield, gloves, rubber boots, and in enclosed spaces, SCBA. Structural firefighters protective clothing will only provide limited protection. Wear self-contained breathing apparatus with a full facepiece operated in the positive pressure demand mode when fighting fires.

Fire fighting equipment/instructions

Keep unnecessary personnel away. Eliminate sources of ignition. Use personal protective equipment. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Avoid contact with skin or breathing spillage, vapors, mist, or gas. Ensure adequate ventilation. Beware of vapors accumulating to form explosive concentrations. Vapors can accumulate in low areas. Prevent further

leakage or spillage if safe to do so. Do not let product enter drains.

6.2 Environmental precautions

Retain and dispose of contaminated wash water. Avoid release to the environment. Contact local authorities in case of spillage to drain/aquatic environment. Prevent further leakage or spillage if safe to do so. Do not contaminate water.

6.3 Methods and material for containment and cleanup

Eliminate all ignition sources. Stop the flow of material, if this is without risk. Dike the spilled material, where this is possible. Absorb with inert absorbent such as dry clay, sand, or diatomaceous earth, commercial sorbents, or recover using pumps.

The product is immiscible with water and will spread on the water surface.

Large spills: Stop the flow of material, if this is without risk. Dike the spilled material, where this is possible. Cover with plastic sheet to prevent spreading. Prevent product

from entering drains. Absorb in vermiculite, dry sand, or diatomaceous earth, and place into containers.

Small spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination.

Never return spills in original containers for re-use. This material and its container must be disposed of as hazardous waste. Collect and dispose of spillage according to local regulations.
