**4.1 General Advice:** Consult a physician. Show this safety data sheet to the doctor in attendance. Move out of dangerous area.

# 5.3 Specific hazards arising from the chemical

Static charges generated by emptying package in or near flammable vapors may cause flash fire. Fire may produce irritating, corrosive, and/or toxic gases.

# 5.4 Special protective equipment and precautions for firefighters

Firefighters must use standard protective equipment including flame retardant coat, helmet with face shield, gloves, rubber boots, and in enclosed spaces, SCBA. Avoid contact with skin or breathing spillage, vapors, mist, or gas. Ensure adequate ventilation. Beware of vapors accumulating to form explosive concentrations. Vapors can accumulate in low areas. Prevent further

leakage or spillage if safe to do so. Do not let product enter drains.

#### 6.2 Environmental precautions

Small spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination.

Never return spills in original containers for re-use. This material and its container must be disposed of as hazardous waste. Collect and dispose of spillage according to local regulations.
